Should an error be made in the amount of any donation, the donor has 5 days in which to notify EFBA of the error. All requests for refunds must be made in writing by email to the Finance Manager <u>finance@efba.us</u>

The request should have the details of the initial donation including the date, amount, the name of the donor, any tax invoice number and the nature of the error. Any tax invoice issued for the incorrect amount immediately becomes void and invalid, and a new tax invoice will be issued for the amount of the corrected donation.

Eligibility for refund is based on when the cancellation request is submitted:

- Cancellation or postponement requests received 5 weeks (or longer) prior to the test day are eligible for a refund, and an administrative fee of \$50 will be deducted from the total amount paid..
- Cancellation requests made less than 5 weeks before the test date are not eligible for a refund.
- Absence on the test day is treated as cancellation and is not eligible for any refund.
- If an application for a Transfer of Test Date is approved, an administrative fee of \$50 will be charged.
- If an application for a refund is approved, the center will issue a refund to the candidate, minus the \$50 administrative fee.
- Latecomers will not be allowed into the test center and no refund or transfer will be processed. Check your "convocation" letter for arrival time information. Candidates must be at the center at least 10 minutes before the test start time and will be considered late if arrival time is less than 10 minutes prior to test start time.

France Education International (ex-CIEP) regulations governing cancellations only allow full refunds in case of emergency, defined as documented illness, transportation problems, or death of a loved one. Candidates who miss their scheduled exam date for one of these reasons may receive a full refund of their registration fees on condition that they provide the France Education International (ex-CIEP) services with official proof / supporting documentation within a week from the test day.
